## NOTICE OF RACE

(revised version dd 16 September 2019)

### GENERAL

#### A.1 LANGUAGE

A.1.1 The official language of the class is English and in case of dispute over translation the English text shall prevail.

A.1.2 The word "shall" is mandatory and the word "may" is permissive.

#### A.2 ABBREVIATIONS

OA = Organizing Authority

IJ = International Jury

WS = World Sailing

RRS = Racing Rules of Sailing

### VENUE

The CLUB LA PELLE Marseille with the collaboration of the French Sailing Federation and the International Nacra 15 Class Association, have the pleasure in inviting you to participate in the Nacra 15 FOILING Championship. The regatta will be sailed from Stade Nautique du Roucas Blanc in front of the coast of Marseille, France.

### ORGANIZING AUTHORITY

The Organizing Authority (OA) is CLUB LA PELLE Marseille in conjunction with the International Nacra 15 Class Association (IN15CA).



## 1. RULES

- 1.1 The regatta will be governed by the rules as defined in *The Racing Rules of Sailing* (RRS).
- 1.2 No national prescriptions will apply.
- 1.3 The Nacra 15 Equipment Inspection Regulations will apply and will be published at the website [www.nacra15class.com](http://www.nacra15class.com).
- 1.4 The Nacra 15 Class Rules will apply.
- 1.5 Any changes in the Notice of Race (NOR) will be published at the website <http://www.nacra15class.com> (RRS 89.2(b))
- 1.6 If there is a conflict between languages, the English text will take precedence.
- 1.7 RRS Appendix T, Arbitration, will apply.
- 1.8 Safety : Helmets shall be worn at all times whilst afloat.

## 2. [DP] ADVERTISING AND IDENTIFICATION

- 2.1 Boats may be required to display advertising chosen and supplied by the Organizing Authority. If this rule is broken, World Sailing Regulation 20.9.2 applies.
- 2.2 If necessary, competitors of the boats ranked first, second and third in the series at the beginning of each day may be required to wear yellow, blue and red bibs respectively while racing. The Organizing Authority will provide the bibs.

## 3. ELIGIBILITY AND ENTRY

- 3.1 The regatta is open to the Nacra 15 FCS, Nacra 15 FCS Single Handed (Mainsail and Kite Only) and the Nacra 15 FCS ONE of the International Nacra 15 class Association.
- 3.2 Minimum age : 16 years on the day of competition. In case one of the crew is 18 years or older the other crew may be < 16
- 3.3 Competitors, coaches and other support persons, shall enter by completing the on-line entry form on the event website <http://www.nacra15class.com> and paying the required fees online. A list of confirmed entries will be posted at the event website.
- 3.4 The request for entry shall be filled in and the entry fees shall be paid before the Early or Entry deadlines (30 September 2019) to get advantage of the reduced entry fees (NOR 4.1). Entries sent after the Late Entry deadline (30 September 2019), but within 14 days of the start of the regatta will be accepted with the required entry fees. Late entries received within 14 days of the start of the regatta will be accepted only at the discretion of the Organizing Authority whose decision shall be final.



3.5. Entry in the event is not final until registration is completed. Registration includes presenting written proof of third party liability insurance.

3.6 Eligibility under World Sailing Regulation 19 shall apply, which requires that all competitors (skipper and all other crew) shall be members of their World Sailing Member National Authority or one of its affiliated organizations. The membership details shall be stated when entering. Proof of membership shall be presented at registration.

3.7 Be a national of the country he or she represents or be an ordinary resident of the country for more than one year and must be able to establish his residency (official residence/work permit, visa etcetera) for this period.

3.8 All competitors (skipper and all other crew) shall be fully paid-up members of the International Nacra 15 Class Association.

3.9 Competitors under 18 years of age shall present a signed and completed parent (or guardian) consent and declaration form (available at the event website).

#### 4. FEES

4.1 Required fees are as follows, payable by banktransfer to NL81INGB 0007 784 073 (BIC/SWIFT code INGBNL2A) in the name of Vereniging International Nacra 15 Class (address Hellingweg 110-116, 2583DX The Hague, Netherlands), referencing Nacra 15 Worlds 2019, name helm and sailnumber. Entry is not completed until the required entry fee is received by the OA.

4.2 Paid entry fees will 50% refunded until 30th September.  
After 30th September entry fees will not be refunded.

4.3. Entry Fees have to be paid in Euro (no other currencies accepted) online. The sender shall pay all cost of money transfer. Any fee to be fulfilled at registration shall be paid in cash and in Euro only.



#### 4.5 CHARTER BOATS :

**Nacra Sailing will make 10 Nacra 15 FCS Charter-boats available. :**

N15 week charter: €1800 without sails and insurance, including transport to the venue.

N15 FCS charter: €950 without sails and insurance, including transport to the venue and FCs spinnaker.

### 5. FORMAT

5.1 The event will consist of a single fleet or depending on the number of a split fleet series divided into a Qualifying Series and Final Series (Gold and Silver fleet).

5.2 An initial split in two fleets may be made based on Class: Nacra 15 FCS / Nacra 15 FCS Single-handed + Nacra 15 FCS ONE.

### 6. SCHEDULE

6.1 Registration for competitors and coaches :  
19 October 0900 1300 and 14.00 1800 hours  
20 October 0900 1300 and 1400 1800 hours  
25 October 18.00 – 21.00 hours

6.2 Equipment inspection: Spot Checks may take place throughout the event.

6.3 Dates of Racing:

26 October 4 races back to back  
27 October 4 races back to back

6.4 The opening ceremony is scheduled for 26 October at 10.00 hours.

6.5 A daily briefing (for all sailors and coaches) is scheduled at 10 a.m.

6.6 The first warning signal for the first race on 26 October is scheduled at 12.00 hours.

6.7 On the last scheduled day of racing, no warning signal will be made after 1600 hours.

6.8 The prize giving and closing ceremony are scheduled to begin as soon as possible after the finish of the last race.



## 7. EQUIPMENT INSPECTION

7.1 Equipment shall be available for inspection by the Technical Committee during the event (NOR 6.2) or as agreed in writing with the Organizing Authority. Details of any pre--first race equipment inspection, location and schedules may be posted on the official notice board and website.

7.2 In accordance with RRS 78, competitors are responsible for maintaining their boat in accordance with the Class Rules (for the purpose of RRS 78, competitors are considered to be the owners). Boats may be subject to inspection at any time during the event. The procedures for inspections will be specified in the Sailing Instructions (SI) or Equipment Inspection Regulations (EIR).

## 8. SAILING INSTRUCTIONS

Sailing Instructions will be available upon registration at the Race Office and will also be published on the Event website. Other documents governing the event will be published with the Sailing Instructions.

## 9. VENUE

Attachment A shows the location of the venue. Attachment B shows the location of the racing area.

## 10. THE COURSES

Racing will take place on courses that may contain upwind, downwind and reaching legs around laid marks.

## 11. PENALTY SYSTEM

11.1 RRS 44.1 is changed so that the Two--Turns Penalty is replaced by the One--Turn Penalty.

11.2 An International Jury will be appointed in accordance with RRS 91(b). Its decisions will be final as provided in RRS 70.5.



## 12. SCORING

12.1 Two races are required to be completed to constitute a series.

12.2 When fewer than five (5) races have been completed, a boat's series score will be the total of her race scores.

12.3 When five (5) or more races have been completed, a boat's series score will be the total of her race scores, excluding her worst score.

## 13. [DP] SUPPORT BOATS AND PERSONNEL

13.1 All support boats shall be registered with the Organizing Authority and will be required to comply with local legislation and event support boat regulations. The Organizing Authority may refuse registrations and accept later registrations at their sole discretion.

13.3 Registered support boats shall act as rescue boats in case of need. If the Race committee displays Code Flag V all the support boats will have to assist with rescue operations as requested by the Race committee.

13.4 Support boats with team leaders, coaches and other support persons shall stay outside areas where boats are racing from the time of the starting sequence until all boats have finished or the race committee signals a postponement, general recall or abandonment.

13.5 Support boats shall be kept in their assigned places at the beach or in the harbor.

## 14. [DP] BERTHING

Boats shall be kept in their assigned places at the boatpark.

## 15. [DP] RADIO COMMUNICATION & DATA

A boat that is racing shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats except in an emergency or when using equipment provided by the Race Committee.



## 16. PRIZES

Prizes will be awarded to :

Nacra 15 FCS Open 1,2,3

The Organizing Authority may award additional prizes.

## 17. MEDIA RIGHTS, CAMERAS AND ELECTRONIC EQUIPMENT

17.1 By participating in the event, competitors automatically grant to the Organizing Authority, and their sponsors, the right in perpetuity to make, use and show, from time to time at their discretion, any motion pictures and live, taped or filmed television and other reproductions of the athlete during the period of the competition without compensation.

17.2 Boats may be required to carry cameras, sound equipment and positioning equipment as specified and provided by the Organizing Authority.

17.3 The top three competitors as well as the individual race winners may be required to attend a media press conference each day.

17.4 Competitors may be required for interviews at the regatta.

## 18. ANTI--DOPING CONTROL

Doping control will be conducted in accordance with the World Sailing Anti--Doping Code 21. In--competition testing may be carried out at the Venue.

## 19. INSURANCE

Each participating boat shall be insured with a valid third party liability insurance with a minimum cover of Euro 1,500,000 (or the equivalent) per incident.

For teams without a third party insurance valid in France, it will be possible to buy a third party insurance to be used during the event.

## 20. DISCLAIMER OF LIABILITY

Competitors participate in the regatta entirely at their own risk. See RRS 4, Decision to Race. The Organizing Authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.
