NOTICE OF RACE

1. RULES

- 1.1 The event is governed by the rules as defined in *The Racing Rules of Sailing* (RRS). Other documents under RRS Definition: Rule (g) include:
 - (a) the Regatta Regulations (RR) of the Hungarian Sailing Federation,
 - (b) the Advertising Code of the Hungarian Sailing Federation, and
 - (c) RRS Appendix T, Arbitration.
 - (d) Nacra15 Class Rules
- 1.2 **[DP]** RRS 40.1 shall apply at all times while afloat.
- 1.3 RRS 90.3(e) shall apply.
- 1.4 The national authority prescriptions that apply are stated in full at [this link](#).
- 1.5 If there is a conflict between languages the English text takes precedence.

2. SAILING INSTRUCTIONS

- 2.1 The sailing instructions will be available no later than the start of registration at the official notice board.

3. COMMUNICATION

- 3.1 The official notice board is available via the <https://spartacus.hu/en/versenyeink/nacra15-europa-kupa-es-orszagos-bajnoksag-2026/> website.
- 3.2 Notices may also be posted on the notice board located at the event venue.
- 3.3 **[DP]** While racing, except in an emergency or when using equipment provided by the organizing authority, a boat shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.

4. ELIGIBILITY, ENTRY AND REGISTRATION

- 4.1 The event is open to all boats of the Nacra 15 class.
- 4.2 Each competitor and boat shall comply with the eligibility requirements in RR 3.
- 4.3 Eligible boats may enter as follows:
 - (a) Athletes holding only Hungarian nationality: in the VIHAR system of the Hungarian Sailing Federation.

 4.6 Registration: at the race office located at the event venue between 8:00-10:00 on 25 August 2026.
 4.7 Each athlete not holding a licence of the Hungarian Sailing Federation under 18 years old on 24 August 2025 shall bring to registration a completed parent/guardian consent form (Attachment B).
 4.8 To be considered an entry in the event, a boat shall complete all registration requirements and pay all fees no later than at registration.

5. FEES

- 5.1 The entry fee for each boat will be as follows:

- 5.2 Entry fees shall be paid by bank transfer (only in EUR currency) before registration, or by cash at registration. Details of the bank transfer are the following:

Fees shall be free of bank commissions. Any bank fee will be charged to the competitors.

- 5.3 Entry fees may also be paid in HUF currency at registration, based on the daily exchange rate.

6. [DP] IDENTIFICATION AND ADVERTISING

- 6.1 When provided by the organizing authority, boats or competitors shall carry, display or wear the following as instructed:
 (a) coloured bibs for leaders (1st, 2nd and 3rd), and
 (b) event advertising.

7. SCHEDULE

- 7.1 Racing days, scheduled time of warning signals and number of races:

- 7.2 On the last scheduled day of racing no warning signal will be made after 15:00.

8. EQUIPMENT

- 8.1 Each boat shall produce or verify the existence of a valid measurement certificate at registration.
 8.2 All boats are required to comply with RRS 78.1 from 11:00 on 25 August 2026 onwards. Non-compliance from 11:00 on 25 August 2026 until the start of the first race shall be reported, protested and penalized as if it were discovered after racing on the first day on which races for that boat have been completed.
 8.3 Penalties for breaches of class rules and RRS 50 may, at the discretion of the protest committee be less than disqualification.

9. VENUE

- 9.1 The event venue will be the port of Spartacus Sailing Club. The address of the port: 8623 Balatonföldvár, Móló
- 9.2 The racing area will be north to Balatonföldvár.

10. THE COURSES

- 10.1 Up and down courses will be sailed with a target time of 30 minutes.

11. PENALTY SYSTEM

- 11.1 RRS 44.1 and the RRS P2.1 is changed so that the Two-Turns Penalty is replaced by the One-Turn Penalty.

12. SCORING

- 12.1 One race is required to be completed to constitute a series.
- 12.2 Four races are required to be completed to constitute a Hungarian Championship series.
- 12.3 (a) When fewer than four races have been completed, a boat's series score will be the total of her race scores.
- (b) When four or more races have been completed, a boat's score will be the total of her race scores excluding her worst score.

13. SUPPORT PERSON VESSELS

- 13.1 For the purposes of these instructions a support person vessel is any vessel with support persons aboard.
- 13.2 Lake Balaton is a nature reserve area and the use of powerboats is strictly regulated by Hungarian law. Only boats with proper permits may be used as support person vessels for the event. Failure to obtain these permits may result in prosecution by the local authorities. There will be a limited number of temporary permits available for support person vessels. In order to obtain one, support person vessels shall initially register by 23:59 on 1 August 2025. To register, please contact the organizing authority for information regarding data to be submitted, fees and the content of the permit.
- 13.3 Support person vessels shall be registered by their drivers during registration. The registered driver(s) of a support person vessel will be responsible for the control of the vessel at all times and will be held responsible for any inappropriate behaviour or dangerous actions, or actions affecting the fairness or safety of competition.
- 13.4 Each support person vessel shall submit the sail numbers of the supported boats at registration.
- 13.5 A team leaders meeting will be held 90 minutes before the scheduled tie of the first warning signal each day.
- 13.6 The use of drones by support boats is prohibited.
- 13.7 The movements of support person vessels will be restricted by the sailing instructions.

14. SUPPORT BOATS AND SUPPORT PERSONS

- 14.1 For the purposes of these instructions a support boat is any boat with support persons aboard.
- 14.2 Every support boat needs registration on Lake Balaton and has to pay 150 EUR/ boat to the National Transport Authority. The balance of fees and the completed registration form shall be received on or before **1 August 2026**

15. [DP] BERTHING

- 15.1 Boats shall be kept in their assigned places in the boat park.

16. DATA PROTECTION AND MEDIA RIGHTS

- 16.1 With regards to data management, please refer to the Data Management Policies of the organizing authority.
- 16.2 By participating in this event competitors and their support persons automatically grant to the organizing authority and their sponsors the right in perpetuity to make, use and show, from time to time at their discretion, any motion pictures and live, taped or filmed television and other reproductions of the persons during the period of the competition without compensation.

17. RISK STATEMENT

- 17.1 RRS 3 states: 'The responsibility for a boat's decision to participate in a race or to continue to race is hers alone.' By participating in this event each competitor agrees and acknowledges that sailing is a potentially dangerous activity with inherent risks. These risks include strong winds and rough seas, sudden changes in weather, failure of equipment, boat handling errors, poor seamanship by other boats, loss of balance on an unstable platform and fatigue resulting in increased risk of injury. Inherent in the sport of sailing is the risk of permanent, catastrophic injury or death by drowning, trauma, hypothermia or other causes

18. INSURANCE

- 18.1 Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of 1.5 million EUR per incident or the equivalent.

19. PRIZES

- 19.1 The following Hungarian Championship prizes will be awarded:
- (a) Nacra 15 top 3 boats.
 - (b) Nacra 15 U17 top 3 boats
 - (c) Nacra 15 U19 top 3 boats
- 19.2 The following Super Series prizes will be awarded (when international boats have entered the event):
- (a) Nacra 15 top 3 boats
 - (b) Nacra 15 U17 top 3 boats
 - (c) Nacra 15 U19 top 3 boats
 - (d) Nacra 15 top 1 girls boat
